Whereas, The PFM principals, namely, the Chairman, Commission on Audit (COA); the Secretary, Department of Budget and Management (DBM); and the Secretary, Department of Finance (DOF), approved, upon the recommendation of the GIFMIS/PFM Committee under Resolution No. 02-2011 dated July 12, 2011, the creation, among other organizational units, a Procurement Unit under the Program Management Office (PMO) that shall be responsible for the acquisition of goods and services for the GIFMIS/PFM projects.

Whereas, The various projects under the PFM Reforms are under way, and goods and services needed in their implementation have to be acquired/procured efficiently, effectively and economically;


Wherefore, The PFM Committee resolves, as it hereby resolves, to designate the following officials and employees of the key fiscal oversight agencies to compose the BAC:




